### EXPLANATION OF REFERENCE MARKS

Explanation of Reference Marks will be found at the foot of the first page on which they appear.

### CHECKING AND FILING OF TARIFFS

▲ A complete set of Tariffs (which are open for public inspection) is kept on hand at various stations from, to or at which rates apply.

It is imperative that such tariffs be filed in a careful and systematic manner, and tariff binders have been furnished for this purpose.

Packages containing Tariffs and Supplements thereto, should be opened promptly and their contents thoroughly examined in order that all concerned may be posted as to any changes affecting stations under their jurisdiction.

Tariffs should be date stamped and filed in binders as soon as received.

Cancelled Tariffs must be removed from binders on date new issues are effective. Such cancelled Tariffs, however, should be retained for a period of three months in case it may be necessary to refer to them.

Tariff binders must be frequently and carefully checked with Tariff Index and Supplements thereto in order to detect errors or shortages. If shortages are discovered, same should immediately be reported to Station Agent, Sept-Îles, Quebec.
